  Eunis Newton Baldwin married Silas I. Baldwin (b.1801) had daughter [Alice] Gertrude Baldwin Richards (b.1834) married John M. Richards (b.1834) of West Haven.

  J.M.Richards owned two vessels: the Schooner John R. Watson and the Schooner

  J.M.Richards built in West Haven.

Genealogy: Thomas Shreeve of N.J. daughter Hope Shreeve Cowperthwaite married William Cowperthwaite, had brother Stacy Cowp., of Phil. William Cowperthwaite was a merchant and owner of the Sloop Mercury.

Genealogy: Archibald Blakeslee, son of Teiley [Tilley] Blakeslee of New Haven, had a daughter Ann Blakeslee.

Archibald Blakeslee of New Haven and New York was a business partner of W.Cowper-thwaite and according to the N.H.Vital Records died in an almshouse in 1830 at the age of 80.
