INTRODUCTION

The Painter/Collins Collection consists of roughly 2,700 documents, mostly private letters, dating from the period 1771-1896. The correspondence centers around the patriarchal figure of Thomas Painter (1760-1847), a prominent citizen of West Haven. Among his varied occupations, Thomas Painter was a soldier, privateer, merchant, ship's captain and storekeeper. The letters of Thomas Painter, as well as his financial papers and autobiography, provide a considerable wealth of information regarding the shipping industry in the last decades of the eighteenth and first decades of the nineteenth centuries.

A considerable correspondence between the daughter of Thomas Painter, Cynthia (Painter) Collins (1791-1880), her husband Simeon Collins (1786-1266) and their children Anna Maria (Collins) Clephane (b. 1835) and Frances A. (Collins) Mitchell illustrate the period of the Civil War in some detail. Also of interest are the letters of two of Thomas Painter's grandsons, David Chittenden Collins (1825-1863) and Thomas P. Collins, who worked as daguerrotypists in Philadelphia in the 1840s and 1850s.

ORGANIZATION OF THE COLLECTION

The papers of the Painter/Collins Collection are organized into five series: financial documents, diaries and literary efforts, school books, correspondence and miscellaneous documents. The collection contains over 2,700 documents, of which some 2,000 are personal letters.

The FINANCIAL DOCUMENTS (Series I) are organized by family member and are further subdivided by topic. Only three family members have financial records in the Collection and the vast majority of these documents are the private papers of Thomas Painter.

The series DIARIES AND LITERARY EFFORTS (Series II) consists of a number of essays and compositions by various family members. In addition, the practice of copying poems published in newspapers and books was common and the Collection contains a number of poems copied from various sources, usually unidentified. It is difficult to establish the authorship of the poems, but it is not unlikely that some of them were actually penned by members of the Painter and Collins families. The organization of this section is by family member, with further subdivisions based on topic.

The following series SCHOOL BOOKS (Series III) consists of practice books for handwriting skills and is organized by family member.

The largest series is the CORRESPONDENCE (Series IV). This series is divided into two main sections: Family Correspondence and Minor Correspondents. The Family Correspondence consists of letters between the thirty-four family members shown in capital letters on the Genealogical Chart in the section of this finding aid entitled "Genealogical Notes". This represents the main branches of the family. The order of the letters is generational. First are the letters of Thomas Painter and his wife, Hannah (Candee) Painter. Second are the letters from their children.

Next are the letters from the grandchildren of Thomas Painter. The letters from the aunt and uncle of Thomas Painter and from the Candee family are placed last in the order.

The second section of correspondence, Minor Correspondents, contains the letters from non-family members and more distant relations. These letters are organized alphabetically.

The final series MISCELLANEOUS DOCUMENTS (Series W) consists of odd papers. Of special interest are genealogical notes and papers concerning the history of the "Collins Mansion".

HISTORY OF THE PAPERS

The original Painter/Collins Collection housed at the New Haven Colony Historical Society consisted of roughly seventy-five documents. These documents were processed in 1980 by Isabelle Gould.

In 1989, a generous gift of over 2,600 documents relating to the Painter/Collins Collection was donated to the New Haven Colony Historical Society by Mr. Winslow Williams of Richmond, Virginia. These documents were processed in the summer of 1990 by Timothy Matney. The addition of this large collection necessitated the reorganization of the old collection. Some of the genealogical and historical information contained within this finding aid has been culled from the original 1980 version written by Ms. Gould.

GENEALOGICAL NOTES

The Genealogical Chart of the Painter and Collins families provided at the end of this section summarizes the relationships between the main correspondents in the Collection. The bulk of the correspondence centers on the figures of Thomas Painter, Hannah (Candee) Painter, Cynthia (Painter) Collins, Simeon Collins, Anna Maria (Collins) Clephane and Frances A. (Collins) Mitchell.

THOMAS PAINTER (1760-1847)

Thomas Painter was born in West Haven in 1760, the son of Joseph Painter, a sailor. Upon his father's death in 1776, Thomas moved to Cheshire where he was raised by his grandmother until the age of eleven. In 1771, he moved back to West Haven and worked on his uncle's farm. In 1776, he enlisted in a military company and was involved in the defense of New Haven in 1779. His autobiography (of which two handwritten and two typescript editions are housed in this Collection) details his early life as a soldier, privateer and merchant. He eventually purchased interests in a number of shipping concerns, served as a ship's captain and worked as a store-keeper on Long Wharf.

Shipping was always a vital aspect of the economy of New Haven. The Colony was proclaimed a 'Lawful Port' in 1702, later possessing its own Custom House.

Thomas Painter was active in this trade from 1784-1814. At that time, the disruption of international trade due to the Napoleonic War meant that the port of New Haven could compete for international shipping with its better situated neighbors of New York and Boston. Economically, the most important part of this trade was the flourishing commerce done with the West Indies. Always an aspect of New Havenbased shipping from the 1760s to the 1880s, the West Indies trade was vital to New Haven's success. Thomas Painter's letters and financial documents mention his participation in this trade, see especially Box 1/Folder K, Orders to Sail,

In 1783, Thomas Painter married Hannah Candee, the daughter of Samuel Candee and Lydia (Sherman) Candee. After Hannah's death in 1830, Thomas married Elizabeth W. Buddington of Hartford.

ALEXIS PAINTER (1794-1867)

Alexis Painter was born in West Haven. He graduated from Yale University in 1815 and went to study law in Litchfield. After a brief career practicing law in Annapolis, Maryland he moved to Westfield, Massachusetts, where he taught and worked as a merchant. In 1852, he retired to West Haven. He was known as an ardent foe of slavery and worked for the temperance reforms movement. In 1826, he married Thalia Maria McMahon (1806-1889) of New Milford. The letters between Alexis and Thalia provide interesting historical insight into the issue of slavery.

SIMEON COLLINS (1786-1866)

Simeon Collins was the son-in-law of Thomas Painter, marrying Painter's daughter, Cynthia Painter in 1815. Simeon was a travelling salesman who dealt in perfume and ink. He travelled extensively in Connecticut, Massachusetts and New York, visiting small towns throughout the region. His extensive correspondence with his wife relates the details of his travels and provides an interesting study of the rural countryside in the first half of the nineteenth century. The letters concentrate on Simeon's work, but are also useful for deriving a chronology of the Collins family.

ANNA MARIA (COLLINS) CLEPHANE (b. 1835)

Anna Maria (Collins) Clephane was the wife of the Postmaster General of Washington, D.C. during the Civil War. For a period of several years, she wrote two or three times a week from Washington to her mother, Cynthia (Painter) Collins.

WOODBRIDGE SAGE OLMSTEAD (1803-1871)

Woodbridge S. Olmstead, originally of Hartford, Connecticut, married Mary

Ann Collins on the 29th of October 1838. She was the daughter of Simeon Collins

and Cynthia (Painter) Collins. Shortly after their marriage, Mary Ann died. After

her death, Woodbridge remained in Florida and eventually married Margaret P. Sanchez

in 1841. They had eight children.

DAVID CHITTENDEN COLLINS (1825-1863)

David Chittenden Collins, son of Simeon Collins and Cynthia (Painter) Collins, was a noted daguerrotypist operating out of Philadelphia. He formed a partnership with his brother, Thomas P. Collins, from 1846-1851. Together they exhibited in the American Institute (1846) and David won two silver medals in the Franklin and American Institute Fair of 1852 (source: Rinhart and Rinhart 1981). Shortly after this, David moved back to the New Haven area.

Researchers should not be confused by references to David Chittenden Collins, as there were at least three family members with this name. Below is a short explanation of their chronology.

In 1768, General Augustus Collins (1743-1814) married Mary Chittenden. They produced a number of children, including Simeon Collins (1786-1866) and the first David Chittenden Collins.

In 1815, Simeon Collins married Cynthia Painter (1791-1880). In 1825, they had a son, whom they named David Chittenden Collins, presumably after his uncle. This David is the daguerrotypist whose letters are found in the Collection. He died in 1863.


A third David Chittenden Collins (1805-1861) was probably a cousin of the daguerrotypist, although documentation is lacking to confirm this hypothesis. This third David married Clarrisa Dana (1812-1911). This branch of the Collins family owned the house at 35 Hillhouse Road in New Haven from 1850 to 1916. That

he is not the <u>son</u> of General Augustus Collins is proved by the fact that, at his birth in 1805, General Collins would have been 62 years old and his would have been in her mid-fifties. More likely, he is from the generation of General Augustus Collins' grandchildren.

GEOGRAPHICAL LOCATION OF THE PAINTER AND COLLINS FAMILIES

Box 11, Folder MM contains various documents regarding the "Collins Mansion" which was located in West Haven until 1961, when it was moved to Litchfield. This was the home of Thomas Painter and Hannah Candee. Of the children of Thomas and Hannah, Cynthia Painter moved to Guilford, Connecticut after marrying Simeon Collins. Later they moved to Westfield, Massachusetts and finally ended up in the "Collins Mansion" in West Haven. Angelina Painter, after her marriage to Rev. Samuel Rich, moved to Sangerfield, New York. The children of Simeon Collins and Cynthia (Painter) Collins moved to various locations across the United States. Cynthia P. Collins, after her marriage to Henry W. Sherman moved to Suffield, Connecticut. Mary Ann Collins, after her marriage to Woodbridge S. Olmstead, moved to Florida. Anna Maria (Collins) Clephane and Walter "Lewis" Clephane lived in Washington, D.C. Frances A. Collins, after her marriage to Joseph G. Mitchell, moved to California, later returning to West Haven. David Chittenden Collins moved to Philadelphia.

He moved back to New Haven in the 1850s.

The following items were purchased by the Whitney Library from funds of the Whitney Library Associates.

Built in 1695 in what is now West Haven, the Thomas Painter House is considered to be the last of its kind in Connecticut. Thomas Painter was born in the house in 1760. His daughter, Cynthia, married Simeon Collins and they had four children, Frances, Thomas, David, and Annie Marie. Thomas P. and David C. Collins became well known as talented daguerreotypists and photographers.

The house passed through two generations of the Collins family, and upon the death of David Collins' daughter, Annie T. Collins Wood (Mrs. A. Felton Wood), the home was inherited by Emily Williams (Mrs. John King Stevenson). Annie had no children and left the home to her good friend, Emily. It was dismantled and reconstructed in Litchfield, Connecticut in the 1960's.



The Registers of Philadelphia Daguerreotypists Simons & Collins, 1845-1854

The opportunity to acquire business records for American daguerreotype operators is rare, so when curators at AAS were contacted by our member David

Doret about a pair of truly remarkable customer registers being offered by a Pennsylvania dealer, we acted quickly. The registers consist of a volume for the firm Simons Collins (Montgomery Simons and the Collins brothers, Thomas and David C.), and



a second volume for its subsequent incarnation, D.C. Collins & Co. (David C. primarily, with Thomas and/or their father, sporadically). Because the Library Company of Philadelphia has excellent examples of the Collins brothers' daguerreotypes, we confirmed that they were not pursuing these records before we acquired them. Library Company curator of prints and photographs Sarah Weatherwax was pleased that they ended up at AAS rather than in the hands of a private collector. They will be available to scholars for future work on the Collins firm, the history of the daguerreotype, and image-making in the United States before the Civil War.

The registers document over 23,000 customers who visited the company's daguerreian rooms in Philadelphia. For the decade covered by the ledgers (1845-1854), each sitter signed the register or was recorded by a clerk. One of the Collins brothers often added comments regarding the weather ("Stormy day," "Clear day," etc.), payment, size of plate taken, and type of case used. The two volumes are peppered with significant names, such as Philadelphia lithographer Albert Newsom, who sat on the very first day the business was open, and the nationally known temperance lecturer John B. Gough, who sat on a cloudy January day in 1846. Sitters also gave their address; while most came from Philadel-

phia, more distant locations, such as Memphis, Tenn., Shrewsbury, Mass., and Trieste, Austria, are also recorded. Often, as is the case with the sitter from Trieste (Stephen Chase), one family member arrived for a session and the next day returned with other family members – in this case Mrs. Chase, who, like her husband, sat for a half plate image. Occasionally, the entries can be frustratingly un-

specific, for example, mentioning only "A Lady," "An Irish Girl," or "Child of the Hill family." The information about cases and plate size is often scratched hurriedly in the margin, along with notes about whether payment was owed. Returns and refusals are also noted, although these occur infrequently, indicating that the photographers, who started the business just six years after the invention of the daguerreotype process, tried their best to get clear images that pleased their clients.

Because the registers have been held privately since being sold by descendants in 2004, they have been used only infrequently by scholars. They are cited in Rebecca Norris's article on the Collins brothers in the 2006 Daguerreian Annual. Scholar Anne Verplanck has also looked at the ledgers for her work on Quakers in Philadelphia and considers them a vital resource for understanding the consumer culture of the era. Since their arrival at the Society this spring, several collectors and scholars have already used the registers, including one working on a biography of Gough and one, from Singapore, working on the history of the daguerreotype.

The Collins registers were purchased with funds pooled from both the manuscript and graphic arts acquisition budgets. The documentation of imagemaking and consumption that they provide will be invaluable to scholars working under the auspices of the Society's Center for Historic American Visual Culture, as well as researchers working in a number of other areas.
