- VII. Biographical note: The printing firm of Tuttle, Morehouse and Taylor
was established in 1859. George Tuttle bought the printing and
book binding plant of Sidney Babcock in 1857, and two years later
merged with Morehouse and Taylor. The latter firm was the successor
to Storer and Morehouse, formerly Storer and Stone. William Storer
was in business prior to 1848, the Babcock printery dated back to 1854.
George Tuttle died in 1872 and his son George H. Tuttle was
admitted to partnership in the same year. In 1891 George W. Taylor
died. His son sold his father's share of the business to John H.
Taylor, a grandson of the original senior partner; George Tuttle.
Arthur S. Garnes was admitted to the firm in 1895. In 1900 C.S.
Morehouse sold his interest in the firm and on Jan. 10, 1900 Tuttle,
Morehouse and Taylor was incorporated.
- VIII. Analysis: The collection consists of two folders. Folder A contains
a booklet on the history of Tuttle, Morehouse and Taylor, and
assorted newspaper clippings of advertisements of firms that later
were joined with Tuttle, Morehouse and Taylor.
Folder B contains legal documents dealing with partnership
and incorporation.
