VII. Biographical note:

Ezra Stiles was born on November 29, 1727 in North Haven, Conn., where his father, Isaac, was pastor of the Congregational Church. In 1742, Stiles entered Yale where he studied mathematics, astronomy and biblical history. After graduating in 1746, he remained in New Haven to study theology, and in 1749, he was appointed tutor at Yale, a position he held for six years.

In 1755 Stiles became pastor of the 2nd Congregational Church of Newport, R.I. During his 20 years at Newport, he served as librarian of the Redwood Library and pursued the study of languages and science as well as fulfilling his pastoral duties. He began writing his Diary in 1769.

In 1778 Stiles was appointed president of Yale College. In addition to serving as president, he, at various times, taught Hebrew, ecclesiastical history, philosophy, science and theology. The papers in the collection reflect this multiplicity of interests.

Stiles died in New Haven on May 12, 1796 at the age of 68. He was survived by his second wife, Mary Cranston Checkley, a son, Isaac (another son, Ezra, Jr. predeceased him), and four daughters.

VIII. Analysis:

The Ezra Stiles Papers were given to the New Haven Colony Historical Society in 1869 by Dr. Elial Todd Foote of New Haven. Dr. Foote's second wife, Amelia Stiles Leavitt Jenkins, was a granddaughter of Ezra Stiles.

The papers, dating from 1682 to 1795, are contained in one box and four oversized folders. Almost all are original manuscripts. They fall into the following categories:

- 1) Correspondence - letters to Stiles

2) Material on Stiles' The History of Three of the Judges of King Charles I, including Stiles' notes for the book and some papers of the John Dixwell family.

3) Personal notes, lists and research on topics of interest to Stiles as well as illustrations for his "Itineraries" and maps and plans of fortifications and towns.

4) Financial affairs: chiefly receipts bills from people in New Haven.

5) Miscellaneous papers collected by Stiles

Most of the material is filed alphabetically by surname or subject. The papers on the history of the three judges (including the Dixwell papers) are filed chronologically.

The last folder in Box I contains an inventory of the Stiles Papers donated to the Society by Dr. Foote. All of the papers listed in the inventory are filed in the collection with the exception of a letter from Sion Seabury to John Harvard, 1774, which is missing.

Index cards for the collection were typed some years ago. All the material indexed is in the collection except for: 1) a coat of arms of the Dixwell, Sampson, Mitchel, and Beardson families, 2) a reprint of an article on Stiles by P.E. Browning (1936), and four line drawings for Stiles' "Itineraries." These items are not mentioned in the Foote inventories. The present collection does contain photo copies of illustrations for the "Itineraries." (Box I, Folder N)

One letter, from Samuel H. Parsons to Colonel John Chandler (1779), which was found with the Stiles' Papers, has been transferred to the Nathan Beers Collection (MSS #32, Box I, Folder G).

Dates of the material appear on the outside of each folder. For a complete description of the contents of the collection, see the Table of Contents, pp. 1-7. The number of papers in each folder is indicated in parentheses.

A further note: The papers are very old, and some are in very poor condition. They should be handled with extreme care.
