- VII. Biographical note: Stirling School was founded by Dr. Dorothy Asch to meet the educational needs of a segment of the primary school population which she felt had been neglected. She was particularly interested in working with "quick-minded" boys and girls. The curriculum of the school was designed to stimulate the student through first-hand experiences with nature, art, music, science and enhanced by field trips to newspapers, radio stations, airports, etc. Classes were kept to a limit of no more than 16 pupils. Each child was allowed to proceed at his or her own pace.

Stirling School was incorporated on Aug.23, 1967. Space was rented in 1967 in the Baptist Church on Shepard Avenue in Hamden. In 1969, a new school building with space for four classrooms was completed on a site on Shepard Avenue, Hamden. By 1974, a national recession was in progress, rising costs and falling enrollment forced the trustees to close the school.

VIII. Analysis:

Materials are essentially arranged in chronological order within each section. Box I contains Board of Directors official records and papers dealing with the organization of the school. Box II contains business records, bills, and tax statements. Box III contains bank statements, cancelled checks, and records of tuition payments. Box IV contains a scrapbook of newspaper clippings and snapshots of the school and its students. Stirling stories are mostly newslatters to parents, informing them of the progress of the school and of its needs. Also included is a copy of the Sunday New Haven Register Sep.20, 1970, pictorial section which has a feature article about Stirling School. Box V contains curriculum materials and student roll books.
