## Introduction

Thomas Phillips (1805-1887) was trained by New Haven's Ritter family, stonecarvers since the mid-eighteenth century. In 1882, Phillips bought out the Ritter firm. Phillips, looking to differentiate his work from the Ritters', began using granite bases for his monuments and moved the company to 148 Sylvan Avenue, New Haven. In 1888, Thomas Bassett (1869-1905) joined the firm as partner, and under his guidance, the firm expanded its product line to include monuments made by other firms. In the 90s, Herman Meister (1871-1958) and Stephen Peck Perkins (1878-1951) joined the firm and through their marketing and a reputation for fine craftsmanship, they made the Phillips Company the dominant monument maker in central Connecticut. However, the last decades of Thomas Phillips & Sons Company brought few big commissions, and their work consisted of reproducing designs made by others until it ceased operation in 1988.

The collection consists of model, pattern, and sketch books used by the designers and carvers (dating back to the 1840s), negotiations with purchasers, financial records, files, correspondence, and hundreds of photographs.
